Waffles from Scratch

1 1/2 cups all purpose flour

1 teaspoon baking powder

1/2 teaspoon of salt

2 eggs, separated

1 cup milk

1/4 cup melted butter

Confectioner's sugar and fresh fruit or maple syrup

Step One:

In large bowl, combine the flour, baking powder and salt. In a small bowl whisk egg yolks, milk and butter. Stir into dry ingredients until moistened.

Step Two:

In small bowl, beat egg whites on medium speed until soft peaks form. Fold into batter.

Step Three:

Bake in preheated waffle iron according to manufacturer's directions until golden brown. Top with confections sugar and fruit or serve with maple syrup.

Payment Plans

& CLIFE

HOA Assessments are due in January and July of each year. We understand that semi-annual payments are not right for everyone. If a homeowner needs to spread your payments out over time, that's an option!

Additionally, setting up a payment plan and remaining in good standing prevents late fees from accruing on the account.

Payment plans are also available to help get caught up on assessments and can be up to twenty-four months long.

CC&R of the Month

All vehicles on the Property, whether owned or operated by the residents or their families and guests, are subject to this Section and Rules adopted by the board. The board may adopt, amend, and repeal rules regulating the types, sizes, numbers, conditions, uses, appearances, and locations of vehicles on the Property. Without prior written board approval, the following types of vehicles and vehicular equipment, mobile or otherwise. may not be kept, parked, or stored anywhere on the Property if the vehicle is visible from a street or from another lot: mobile homes, motor homes, busses, trailers, boats, aircraft, inoperable vehicles, commercial truck cabs, trucks with tonnage over one ton, vehicles which are not customary personal passenger vehicles, and any vehicle which the Board deems to be a nuisance, unsightly, or inappropriate. This restriction includes overnight parking on streets, driveways, and alleys.


This restriction does not apply to vehicles and equipment temporarily of the Property in connection with the construction or maintenance of a dwelling. Vehicles that transport inflammatory or explosive cargo are prohibited from the Property at all times. The Association may effect the removal of any vehicle in violation of this Section or the Rules without liability to the owner or operator of the vehicle.



What does this mean?



All trailers, boats, RVs, etc. must have prior written approval from the Board of Directors in order to be parked in view of the community. Approvals are considered on a case-by-case basis. Approvals are valid for a sixmonth time frame, once the approval expires a new request is needed. Any boat, trailer, RV etc. that does not have current prior approval from the Board is subject to a violation. Please request approval via www.patriotestateshoa.com.
